I hereby revoke all wills and testamentary dispositions at any time heretofore made by me and do declare this to be my last will and testament I appoint my wife wre Emilie Ginsburg my son Benedict William Ginsburg and Mr G F Barwick (Assistant Keeper of Printed books at the British Museum) and the sirvivor and survivors of them to be EXECUTORS AND TRUSTEES of this my will I declare that all the printed books of my works at my residence are already the separate property of my wife the said Mrs Emilie Ginsburg I give devise and bequeath all my estate and property both real and personal and whether in possession reversion remainder expectancy or otherwise howsoever unto my said executors and trustees (hereinafter called "my trustees") Upon trust to forthwith sell and dispose of the same and with power to give good and valid discharges for the purchase moneys thereof Provided always that my trustees shall have the fullest power and discretion to postpone the sale of the whole or any part or parts of my estate during such period as they shall think proper or to retain the same or any part thereof in its present form of investment without being responsible for loss and that the income of such part of my estate as shall remain unsold shall be applied as if the same were income arising from investments of the proceeds of sale thereof And I direct my trustees out of the proceeds of sale of my said estate and property to pay my debts and funeral and testamentary expenses And subject thereto to stand possessed of the proceeds of sale of my said real and personal estate Upon trust (subject to the overriding power hereinafter contained) to divide the same into five equal parts or shares and to invest the same respectively in their names. And to stand possessed of one of such five parts or shares for each of my five children hereinafter named wis the said Benedict William Ginsburg Ethel Margaret Ritchie (wife of Mr Robert O Bitchie) Mrs Emilie Catherine Mackinder (wife of Halford J Mackinder) Hildegarde Bestrice Hinde (wife of Sidney Langford Hinde) and Sybil Gwendolen -Spottiswoode (wife of Captain John Spottiswoode) and to pay the income and annual produce arising from the investments of such one fifth shares respectively to my said sen and daughters respectively during their lives and after the death of any one of them I give his or her one fifth part or share (subject to the power hereinafter centained) to The British and Foreign Bible Society including any copyright or benefit of publications which my trustees may acquire after my decease And I direct that the receipt of the Treasurer or other proper officer of The British and Foreign Bible Society shall be a good and sufficient discharge to my trustees Provided always and I hereby declare that notwithstanding the trusts hereinbefore declared my trustees shall have power to retain the whole or such part as they in their absolute discretion shall think fit of the proceeds of sale of my residuary estate whether before or after the division thereof into fifths as aforesaid and also after the decease of any child of mine to retain the whole or any part of such

deceased childs share and to apply and expend the moneys so retained in publishing in England or elsewhere any works of mine left by me in manuscript or in defending or preserving by legal proceedings or otherwise the copyright in England or elsewhere in any published or unpublished works of mine And I declare that his power of retainer may be exercised by my trustees at their discretion for the purpose of providing for any future expenditure my trustees may think probable or possible for the purposes aforesaid and that my trustees shall not be bound to pay any moneys to The British and Foreign Bible Society until they have provided for the purposes aferesaid And I declare that my trustees shall be the sole judges whether or when any works of mine shall be published or whether or when the copyright in any works of mine published or unpublished shall be sold Provided always that if my trustees retain any moneys from the shares set apart for my said children they shall be retained from all such shares equally IN WITNESS whereof I have hereunto set my hand this twenty first day of October One thousand nine hundred and thirteen CHRISTIAN D GINSBURG Signed by the said Christian David Ginsburg the testator as and for his last will and testament in the presence of us both being present at the same time who in his presence and in the presence of each other have hereunto subscribed our names as witnesses -ARTHUR G HERBERT 10 Cork Street W Solicitor S STEWART BROWN 10 Cork Street W Solicitors Clerk
